Our partner supports the civic participation especially that of women in the democratic process and strengthening democratic institutions mainly on the local level. Hanns Seidel Foundation support our activities in the thematic area of huma rights specifically in the prevention of human trafficking. Currently, HSF support our 3 years project on Strengthening and Sustaining Response to Trafficking in Persons in Tanzania

Trafficking in person means the transportation, recruitment. transfer, harboring or receipt of person by means of the threat or use of other form of coercion of abduction, of fraud of deception, abuse of power or of a position of vulnerability or of the giving or receiving of payment to achieve the consent of person having control over another person for the purpose of exploitation.

It's a long-standing feature of the socio-economic landscapes both in developed and developing nations.

It is intertwined with human rights violations. It is a third lucrative crime behind drugs trafficking and illegal arms dealing.

Tanzania enacted Anti the Trafficking in person Act of 2008 which provide the enactment of measures and development programs to promote human dignity and protect the people from threat of violence and exploitation and aims to eliminate trafficking in person and ensure recovery, rehabilitation and re integration for victims of trafficking.

- Signs of physical abuse, physical restraint, confinement
- Signs of emotional or verbal abuse, fear. anxiety, submissive behaviors, or nervousness.
- Lack of documents, money, personal possession held another person
- No freedom of movement and/or constantly monitored bv employer/exploiter
- Restricted, controlled communication
- Numerous occupants in small residency
- Always accompanied by another person when in public
- Outside locks and doors and windows
- Lack of identification documentation
- Unpaid, paid very little, or only earn money through tips
- No permitted work breaks or days off and working long hours
- Dependent on controller/employer for necessities, food, housing.
- Move in groups while travelling on public transport: for example, they may walk up and down the length of trains
- Participate in the activities of organized criminal gangs
- Be part of large group of children who have the same adult guardian
- Be punished if they do not collect or steal enough
- Be part of large group of children who have the same adult guardian
- Be punished if they do not collect or steal enough
- Move from one brothel to the next or working in various locations
- Be escorted whenever they go to and return from work and other outside activities.

ACTIVITIES DONE BY TANZANIA RELIEF INITIATIVES

Once again, I welcome all of you to read this newsletter in order to understand the different activities done by TRI.

This newsletter brings you the briefs about capacity building training that was done from 17 march 2021 to 19 march 2021 at Seacliff in Dar es Salaam and capacity building and training that was done from 19 may to 21 may 2021 in Mwanza. All the activities promote education and raising awareness about how to combat trafficking in person.

The heinous crime of trafficking in person leaves scars that are felt both by the trafficked individual and the society which they originate. The majority of Victims of trafficking in person are women and children. They are mostly experiencing emotional trauma and mental health disorder. They also might suffer from physical health and sexual reproductive disorder.

Capacity building training of police officers, immigration officers, prosecutors and magistrates held in Dar es Salaam and Mwanza which was offer by Tanzania relief initiates promote different topics about trafficking in person like:

LAUNCH OF TANAHUT THAT TOOK PLACE AT DMI SPRING OF HOPE

Tanzania network against human trafficking (TANAHUT) is a loose coalition of human rights CSO, faith-based organization, media organization, higher learning institutions and service providers for victims of human trafficking. It is a member-based network constituted of 45 legally recognized institutions from the United Republic of Tanzania. This network was officially launched on 29th July 2021, during the commemoration of international day against human trafficking.

Its goal is to enhance a coordinated counter trafficking activities in Tanzania. The coalition is determined to leverage available initiatives to actively

- Engage in awareness raising on human trafficking from bottom-top,
- To encourage and promote research both academic and scientific with the view to update magnitude data on human trafficking,
- To conduct legal and policy review and analysis with the view to strengthen the legal framework combating.
- Cooperate with government agencies and development partners to strengthen government institutional and human capacity in combating human trafficking in Tanzania.

This coalition is governed by MOU entered by its founding members and Tanzania Relief Initiatives (TRI) is the convener and coordinating agency for this network.

On 29th July 2021, Tanzania Relief Initiatives joined hands with other 44 organizations to launch a member-based network to combat human trafficking in Tanzania. This launching was hosted by DMI-spring of hope one of the member organizations which deals with rescue and rehabilitation of victims of human trafficking. The launching started from 09:00 am to 05:00 pm and it went together with the national dialogue on the situation of human trafficking in Tanzania. Different participants from different organizations had presentation on different topics of human trafficking.

The launch event involved of 150 participants constituted of members from NGOs, FBOs, Media organizations and Academia (Higher Learning Institutions). Also, there was government representative from the office of the President, Regional administration and local government (PO-RALG), Ministry Home Affairs. of representative from police force as well as Counsellor representatives from Kimara ward in Dar es salaam region.

The TANAHUT launching event was officiated by the Lord Mayor of Ubungo Municipal Council Mr. Jaffary Juma Nyaingesha. Also, there was national dialogue of human trafficking situation in Tanzania which was conducted by the chairman of the network Mr. Edwin Mugambila. Different printing, radio, and TV such as ITV, TBC1, Channel 10, and BBC radio covered the event.

Finally, there were songs and drama from TIP survivors. The plight of the TIP victims is the plight of us all. Let's take action


