# MINUTES OF 3<sup>RD</sup> MEETING OF TANZANIA NETWORK AGAINST HUMAN TRAFFICKING (TANAHUT) CONVENED ON 13<sup>TH</sup> AUGUST, 2021 AT TANZANIA RELIEF INITIATIVES HEADQUARTER





#### 1. Introduction

On 13<sup>th</sup> August, 2021 the network had its 3<sup>rd</sup> meeting held at Tanzania Relief Initiatives office at Mikocheni, Dar es Salaam with the following agenda: evaluation of launching event of Tanzania Network against Human Trafficking in Tanzania (TANAHUT) which was held on 29<sup>th</sup> July, 2021 at DMI spring of hope; review of the 1<sup>st</sup> draft of memorandum of understanding; selection of logo; organizations' profiles and miscellaneous. However, the meeting was attended by 22 network members who played vital role in ensuring the meeting was successful other 23 members sent their apologies.

#### 2. Agenda

#### 2.1 Opening the Meeting

The meeting started at 10:30 AM with a prayer by Mr. Ruta Mutakyahwa. Then followed by short introduction from representatives of different organizations and religious institutions who are members of the network.

#### 2.2 Evaluation of Launching Event of Tanzania Network Against Human Trafficking

The coordinator of the network, Mr. Erick Kimashi from Tanzania Relief Initiatives provided a brief background of TANAHUT launching event held at DMI Spring of Hope, on 29<sup>th</sup> July, 2021. The major objective of the event was to launch the network which has been formed with the prime aim of combating trafficking in persons which mostly affect women, girls and young boys.

#### 2.2.1 Evaluation Comments

One member from Action for Change commented that the executive committee and coordination team of the network did well in coordinating all the activities of the launching event. He recommended that, in next events of the network all members must participate accordingly in the activities of the network to make sure all areas are covered.

Director from TAWOJAC added, that there is need for strong corporation among the network members in every operation of the network because I observed in the event only few people were the one who did all the activities while other members were like invited guests.

Another member opined that in the next event there must be enough t-shirts for all members of the network in order to avoid complaints and other inconveniences.

#### 2.3 Review of 1st Draft of Memorandum of Understanding (MoU)

The coordinator summarized the contents of 13 articles of MoU 1<sup>st</sup> draft to the members of the network as they requested in order to understand its gist and be able to provide views and comments.

#### 2.3.1 Comments on MoU 1st Draft

Mr. Ruta Mutakyahwa observed that the MoU preamble had a lot of grammatical errors which needed to be edited in order to have good document. For example, he found that there's improper use of words in the sentence which distort the message intended to the prospective signatories of MoU.

Another member from CHAKUA recommended that the executive committee and the technical team which are drafting the MoU must ensure all the logo of network members appear in the document. He further opined that the MoU must show the eligibility criteria for a member who want to join the network.

He continued to say that MoU may have a sub-clause which show that there will be a strategic plan of three to five years which guide all the operations based on the priorities that will be agreed by members of the network.

Representative from Action for Change needed to know if the MoU have provided the procedures that will be used to form the executive committee, time limit of holding the positions, if not it is important there must be a clause in the MoU clearly stipulate the procedural information.

In view of the above comments, the Country Director from DMI Spring of Hope Sr. Fatima recommended that the membership clause in the MoU must show that there will be membership subscription fee for other members who will want to join the network. She advised that the MoU must outline the benefits which the members will earn once they wish to join hands in the network.

Another member suggested that the MoU must be in English and Kiswahili to suit all the future members from different settings of community who want to join the network. He

continued to propose that MoU shall state the qualifications for individuals who will want to join the network.

It was also proposed that the MoU may have the clause which declare that the network may be registered subject to members' agreement and executive committee approval.

must have a picture which depict the problem of human trafficking which the network vow to fight.
